### **Customers**

As manufacturer of the products listed in No. 1 we can make the following statement:

1. Products:

All products marketed in the European Union.

2. Hereby we confirm that we meet all corresponding requirements of **REACH - REGULATION (EC) No 1907/2006** that are applicable to our company respectively our products.

We are in active dialog with our suppliers to reassure that registration of chemicals substances, the chemical composition of our products as well as the information flow within the supply chain fully complies with the demands of REACH.

a. **Registration**

All substances that we use for manufacturing our products in quantities of more than 1 ton per year are registered by our suppliers.

Mixtures, such as paints, varnishes, modelling clay, etc., do not have to be registered directly as such, but only their ingredients, which are produced or imported in quantities of more than 1 ton per year. The same applies the writing media released from our products, such as inks, pastes, gels, etc. The registration obligations are also complied with here.

b. **Information on Substances of very high concern (SVHC)**

We keep monitoring the substances on the candidate list and immediately consider any additions. The candidate list includes all substances that have been identified as substances of very high concern (SVHC) and may be transferred to Annex XIV (substances subject to authorisation).

According to REACH Article 33, we must inform downstream users and consumers about the presence of SVHC in our products if they are present in a concentration of more than 0.1 % by weight. A list of our corresponding products can be found under the link <https://www.staedtler.com/REACH>.

This information is also submitted to the SCIP-Database. Articles containing SVHC at a concentration above 0.1 % must be notified according to Article 9(1)(i) of the Waste Framework Directive 2008/98/EC.

c. **Authorisation**

Within our production, we do not use substances listed in Annex XIV.

Our mixtures including the writing media released from our products do not require authorisation.

d. **Restriction**

All products meet the applicable requirements of Annex XVII (Restrictions on the manufacture, placing on the market and use of certain dangerous substances, mixtures and articles).

Our suppliers undertake to comply with the relevant requirements. In addition, we carry out regular tests on the chemical composition of our materials.

3. We take all necessary measures to ensure the future production and marketability of our products. Our suppliers are obliged to comply with the relevant requirements. We make sure that all substances we use in our products in quantities of more than 1 ton per year are registered by our suppliers. In addition, we regularly test the chemical composition of our materials.
